Terms & Conditions

Promotional period and eligibility

- 1. The promoter of this promotion is Wholesale Distributors Limited (t/a FreshChoice supermarkets), 29 Byron Street, Sydenham, Christchurch 8023 ("Promoter").
- 2. This Promotion runs from 11/11/25 until 13/11/25 ("Promotional Period").
- 3. This promotion is open to New Zealand residents aged 18 years or older who own or create a Facebook account. Employees of the Promoter are excluded from participating in this promotion.

Prize
