

Terms and conditions of the RJ's Mega Bag Giveaway Promotion

Promotional period and eligibility

1. The promoter of this promotion is Wholesale Distributors Limited (trading as FreshChoice supermarkets), 80 Favona Road, Mangere, Auckland 2024 ("**Promoter**"). The prize provider of this promotion is RJS Licorice (NZ) Limited, c/a PricewaterhouseCoopers, Level 26 PWC Tower, 15 Customs Street West, Auckland 1010.
2. This Promotion runs from 20/04/26 until 17/05/26 ("**Promotional Period**").
3. This promotion is open to New Zealand residents aged 18 years or older who shop in-store (only) at FreshChoice (excluding SuperValue stores). Employees of the Promoter are eligible to participate in this promotion.

Prizes

4. There are seventy two (72) prizes to be won nationwide, one (1) per FreshChoice store ("**Store**"). Each prize consists of one RJ's Mega Bag (a selection of 24 x RJ's family bags) ("**Prize**").
5. Each Prize must be collected by the selected winner from the Store where their entry was submitted.

Method of entry

6. During the Promotional Period, customers are able to enter the promotion by purchasing two (2) or more products from the "Rj's" and/or "Rj's Fabulicious" ranges ("**Participating Products**") in one transaction in Store. To enter, customers must provide the requested details directly on their original register receipt and place it into the designated entry box.
7. Entry is limited to one entry per transaction. Multiple entries are permitted during the Promotion period. The entry date is the transaction date, which must be during the Promotional Period.
8. The Prizes are not transferable, redeemable and may not be exchanged for cash.
9. The Promoter reserves the right, in its discretion, to remove products from or to introduce further products to the list of Participating Products during the Promotional Period.

Winners

10. **Prize draw** - seventy two (72) winners will be selected via random draws from all valid entries submitted to the entry box at each Store on 17/05/26 ("**Draw Date**"). The draw will be conducted by each Store.

11. Each Store will contact the relevant winner. The winners will be notified by telephone and/or email using the details listed on the winners' entry form. It is up to customers to ensure that their relevant details on their entry form are correct. Details can be updated by contacting the Store where their entry was submitted.
12. In the event a winner cannot be contacted (that is, cannot be reached by telephone and/or does not respond to email) **within seven (7) calendar days of the Draw Date**, a winner will be redrawn on the same terms as the original draw. This process will continue until a winner is able to be contacted.
13. Prize collection will be arranged at a time mutually agreed upon by the winner and the relevant Store.
14. The winners may have their details published on the FreshChoice website or social pages following the Draw Date. By accepting the Prize, the winners consent to their first name, last initial and the relevant Store name and/or photograph being used for such publicity purposes as reasonably determined by the relevant Store. The winners agree to make themselves reasonably available for this purpose, without compensation.

Exclusions and liability

15. The Promoter will not be responsible for any late, lost or misdirected entries.

The Promoter and its related companies, employees and agencies shall not be liable for any loss, damage or personal injury suffered by any person arising directly or indirectly out of or in connection with entering this promotion or claiming/winning any prize, or availing themselves of any prize, except as required by law.
17. The Promoter is not responsible for the transmission or receipt of any incorrect information associated with entries.

Use of personal information

19. The Promoter may use entrants' personal information from entries to conduct the promotion. The Promoter may use winners' personal information for such publicity purposes as reasonably determined by the Promoter.
20. By entering this promotion, entrants consent to the use of their information as described above.
